Terms & Conditions

1. The Website and all stipulations herein refer to the Terms of Use applicable to all users either as a guest or Registered User. All users are required to read carefully these terms of use before using the Website. The use of the website indicates that user accepts and abides with the terms of use.

In case user does not agree with the terms of use, user should immediately cease using the website.
